Whereas it appears to the Governor of Punjab that to meet the challenge of rapid growth of Dasuya Town and to provide for a workable framework for comprehensive planned and regulated development of Dasuya Town and its surroundings in orderly manner and to prepare its Master Plan under "The Punjab Regional and Town Planning and Development Act.1995", the Governor of Punjab is pleased to declare the Local Planning area of Dasuya Town within the meaning of sub section(1) of section 56 of the Punjab Regional and Town Planning and Development(Amendment) Act.2006. The total area proposed for Local Planning Area, Dasuya Town is 7169 Hectares which includes one Urban Settlement. Municipal Council Dasuya and adjoining 42 villages (Total 43 villages). The schedule of boundary of Local Planning Area is as under:-

**Schedule of Boundary:-**

**NORTH:** Starting from point 'A' which is the common meeting point of villages Baja Chak (H.B 197), Sadarpur (H.B 196) & Devi Dass (H.B 198), then moving towards east along the northern boundary of village Sadarpur (H.B196 ), thence along the western ,northern and eastern boundary of village Lamin (H.B 194), upto point 'B' which is the common meeting point of village Lamin ( H.B 194), Unchi Bassi (H.B 195), Jamalpur Kalan (H.B 193).

**EAST:** Thence from point 'B' moving towards south along the eastern boundaries of village Unchi Bassi {H.B.195}, village Chak Kasim {H.B.No.150}, Village Mian Da Pind {H.B.No.152}, village Sarinhpur {H.B.No.139}, village Chak Mehra {H.B.No.137}, village Jalota {H.B.No.135}, village Odrah {H.B.No.134}, village Saggal {H.B.No.110}, village Gangian {H.B.No.111}, village Randhawa {H.B.No.96}, village Nussa {H.B.No.95} up to point 'C' which is the common point of village Nussa {H.B.No.95}, village Kala Jhingar {H.B.No.82} and village Bhana {H.B.No.3}

**SOUTH:** Thence from point 'C' moving towards North along the western boundary of village Nussa {H.B.No.95}, thence moving towards west along the southern boundary of village Ajmer {H.B.No.94}, village Bodal {H.B.No.93}, thence moving towards south along the eastern boundary of village Rajpur {H.B.No.85}, village Khun-Khun Khurd {H.B.No.86}, thence moving towards west along the southern boundary of village Khun-Khun Khurd {H.B.No.86}, thence moving along the Eastern and Southern boundary of village Ralhan {H.B.No.73} up to point 'D' which is the common point of village Ralhan {H.B.No.73}, village Jia Natha {H.B.No.70} and village Ranwan {H.B.No.72}.



WEST:

Thence Starting from point 'D' moving towards north along the western boundaries of village Ralhan (H.B.No.73), village Shahpur (H.B.No.89), village Jhingar Kalan (H.B.No.92) up to link road from Kathana to Dugri, thence along link road from Kathana to Dugri up to village boundary of village Dugri (H.B.No.116), thence moving towards north along the western boundary of village Dugri (H.B.No.116), village Kainthan (H.B.No.131), village Khairabad (H.B.No.130), village Kotli Khurd (H.B.No.123), village Fateh-Ulla-pur (H.B.No.129), Mahadipur (H.B.No.146), village Ashrafpur (H.B.No.143), village Sehge (H.B.No.149) and village SadarPur (H.B.No.196) up to point 'A' which is the point of start.

The boundaries of Local Planning Area Dasua are specifically Shown on the Drawing No. DTP (H) 132/ 10 dated 11.05.2010. All the provision laid down under section 56(2) of "The Punjab Regional & Town Planning and Development (Amendment) Act, 2006" and all the concerned Rules framed under this Act have been taken in to consideration.
