

- Consequent is the issue of Occupation Certificate, the allottee is required to seek Sewerage Connection from the competent authority of GMADA, before connecting its sewer to the street sewer. **Making House Sewer Connection without getting the prior approval will attract penalty and other suitable action.**

- Self attested copy of Occupation Certificate issued by the Estate Officer.
- Certificate from a plumber registered with the Authority in the prescribed form. List of such plumbers is placed at page 7.
- Demand Draft towards road cutting charges, if any, as per the following norms.
